2. Naturaleza de la fuerza

Dado que las cargas son de signos opuestos (+ y -), la fuerza será de atracción. Es decir, ambas cargas se atraen mutuamente.

3. Dirección de la fuerza

La fuerza actúa a lo largo de la línea que une las dos cargas. La carga q_1 experimentará una fuerza dirigida hacia q_2 , mientras que q_2 también será atraída hacia q_1 . La dirección de la fuerza en cada carga es en línea recta, apuntando en sentido opuesto a la otra carga, debido a la atracción.

1. Dirección: desde q_2 hacia q_1 (porque q_1 es positiva y q_2 negativa, la fuerza será atractiva).

from q_2 (4,0) to q_1 (0,0):

$$\Delta x = -4, \Delta y = 0$$

$$r = 4 \text{ m}$$

Unidad vector:

$$u_{12} = (-1, 0)$$

1. Fuerza vector:

$$F_{12_vector} = F_{12} u_{12} = (-3.37 \times 10^{-3}, 0)$$

Fuerza entre q_2 y q_3

1. Distancia r_{23} :

$$\Delta x = 2 - 4 = -2 \text{ m}$$

$$\Delta y = 3 - 0 = 3 \text{ m}$$

$$r_{23} = \sqrt{(-2)^2 + 3^2} = \sqrt{4 + 9} = \sqrt{13} \approx 3.6056 \text{ m}$$

1. Magnitud:

$$F_{23} = k |q_2 q_3| / r_{23}^2$$

$$= 8.9875 \times 10^9 (3 \times 10^{-6} 1 \times 10^{-6}) / (13)$$

$$= 8.9875 \times 10^9 3 \times 10^{-12} / 13$$

$$\approx (8.9875 \times 3 / 13) \times 10^{-3}$$

$$\approx (26.9625 / 13) \times 10^{-3}$$

$$\approx 2.075 \times 10^{-3} \text{ N}$$

1. Dirección:

from q_2 (4,0) to q_3 (2,3):

$$\Delta x = -2, \Delta y = 3$$

1. Unit vector:

$$u_{23} = (-2 / 3.6056, 3 / 3.6056) \approx (-0.555, 0.832)$$

1. Force vector:

$$F_{23_vector} = 2.075 \times 10^{-3} (-0.555, 0.832)$$

$$\approx (-1.152 \times 10^{-3}, 1.728 \times 10^{-3})$$

Paso 3: Sumar las fuerzas vectoriales

Sumamos las componentes en x e y:

1. Componente x:

$$F_x = (-3.37 \times 10^{-3}) + (-1.152 \times 10^{-3}) = -4.522 \times 10^{-3} \text{ N}$$

1. Componente y:

$$F_y = 0 + 1.728 \times 10^{-3} = 1.728 \times 10^{-3} \text{ N}$$

Paso 4: Determinar la magnitud y dirección de la fuerza neta

1. Magnitud:

$$F_net = \sqrt{ F_x^2 + F_y^2 }$$

$$= \sqrt{ (-4.522 \times 10^{-3})^2 + (1.728 \times 10^{-3})^2 }$$

$$\approx \sqrt{ 20.45 \times 10^{-6} + 2.987 \times 10^{-6} }$$

$$\approx \sqrt{ 23.437 \times 10^{-6} }$$

$$\approx 4.841 \times 10^{-3} \text{ N}$$

1. Dirección:

$$\theta = \arctangent(F_y / F_x)$$

$$= \arctangent(1.728 \times 10^{-3} / -4.522 \times 10^{-3})$$

$$\approx \arctangent(-0.382) \approx -20.9^\circ$$

Dado que F_x es negativo y F_y positivo, el vector apunta en el segundo cuadrante, por lo que la dirección respecto al eje x positivo es aproximadamente 159.1° (desde el eje x en sentido antihorario).
